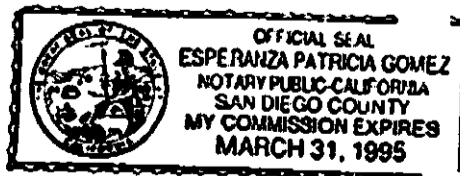

**LEGAL DESCRIPTION
ORDER NO 9104270-D**

All of Lot "A" and a portion of Lot "L" in Block 393 of HORTON'S ADDITION, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by L. L. Lockling and filed in the Office of the County Recorder of San Diego County, together with a portion of Upas Street vacated and closed to public use, September 25, 1912, by Resolution No. 11842 of the Council of the City of San Diego and a portion of Arroyo Drive vacated and closed to public use, July 17, 1912, by Resolution No. 21677 of the Council of the City of San Diego, more particularly described as follows:

Commencing at the Southwest corner of said Lot "A", thence North along the West line of said Lot "A" and the Northerly prolongation thereof a distance of 70 00 feet to the Southwest corner of that certain parcel of land conveyed to the City of San Diego, by Deed dated November 9, 1912, and recorded in Book 587, page 235 of Deeds; thence East along the South line of said parcel of land so conveyed and along the Easterly prolongation thereof to a point that would be intersected by the Northerly prolongation in a direct line of the West line of Lot "L" in said Block 393 of HORTON'S ADDITION, thence East along said prolongation of the South line of said Parcel of land conveyed to the City of San Diego and along the South line of that certain other parcel of land conveyed to the City of San Diego, by Deed dated November 9, 1912, and recorded in Book 587, Page 235 of Deeds, a distance of 20 00 feet; thence South to a point on the South line of said Lot "L" and along the South line of said Lot "L" and Lot "A" to the Point of Commencement
