Dear Honorable Mayor Sanders and Council President Peters:

We feel compelled to notify you of the unprofessional and unethical behavior of your legal representative, the City Attorney.

Late in the day on August 15, 2007, just before SDCERS' General Counsel Christopher Waddell was leaving the country for two weeks with his family, Mr. Waddell received a telephone call from the City Attorney. The call was apparently prompted by Mr. Waddell's letter to Scott Chadwick notifying the City of SDCERS' position concerning the retroactive application of certain benefit changes.

During the telephone call, the City Attorney threatened Mr. Waddell personally, asserting that the City Attorney would sue Mr. Waddell to "take his assets," that Mr. Waddell was not a pension lawyer but was rather an "attorney for the unions," a "tool" of labor and part of "a continuing conspiracy involving pension issues in the City." The City Attorney also told Mr. Waddell that he should realize that his "personal assets are in jeopardy." We understand that Mr. Aguirre's comments were heard by others who were in his office at the time.

Moreover, in a follow-up letter to Mr. Waddell, dated August 24, 2007, the City Attorney again threatened Mr. Waddell by asserting he would be "taking all necessary legal actions to counter SDCERS...including a malpractice action against [Mr. Waddell]..." (copy enclosed).


For the City Attorney, your legal representative and the City's top elected law enforcement officer, to threaten personally another public official in the proper performance of his duties likely violates California and City ethics and administrative policies, is an offense against SDCERS and a violation of professional ethics. Intimidation by personal threat under color of law has no place in a civil society, and we intend to explore the availability of sanctions against the City Attorney by the appropriate authorities.
